# PROSPECTUS FOR ADMISSION INTO LL.B. THREE YEAR COURSE (CHOICE BASED CREDIT SYSTEM SEMESTER PATTERN) ACADEMIC SESSION 2020-2021

The instructions and information given hereunder shall be followed scrupulously.

#### 1. ADMISSION SCHEDULE:

- i) Availability of Online Application Form: In the website <u>www.bamu.nic.in</u> from 03/09/2020
- ii) Last date for receipt of Filled in Downloaded Application form alongwith all required documents and Bank Draft by Regd./Speed Post : 03/10/2020
- iii) Intake Capacity: 160 (One Hundred Sixty)
- iv) College Timing: 10.30 AM to 4.30 PM.
- v) Commencement of 1st year classes : 01/12/2020

The applicants, before applying to LL.B. (3 Year Choice Based Credit System Semester Pattern) course are advised to carefully go through the Berhampur University website <a href="www.bamu.nic.in">www.bamu.nic.in</a>. to know about the Prospectus. They are also advised to visit the Premises of Lingaraj Law College and if so desired, they can see for themselves, the available infrastructure and other facilities. If satisfied, they may apply to LL.B. (3 Year CBCS Semester Pattern) course as per their eligibility. Once admitted, making any unreasonable demand thereafter shall not be entertained and it shall be treated as an act of indiscipline.

## 2. ADMISSION INTO LL.B. THREE YEAR COURSE (CHOICE BASED CREDIT SYSTEM SEMESTER PATTERN)

- i. Admission into the aforementioned course shall be governed by the Regulations of Berhampur University and Rules for admission approved by the Syndicate of Berhampur University.
- ii. A candidate whose conduct is not satisfactory shall not be considered for admission.

#### 3. RULES FOR ADMISSION OF FOREIGN STUDENTS:

No candidate from a Foreign country will be considered for admission unless his/her case has been sponsored by the Government of India in the relevant Department/Ministry. The sponsored candidates are required to produce a Medical Fitness Certificate from a Registered Medical Practitioner not below the rank of a C.D.M.O. in the prescribed proforma within a month of their provisional admission besides other documents required under the rules, instructions of the Government of India/ Odisha. Foreign students who have passed the qualifying examination from a Foreign country taking admission in Lingaraj Law College have to pay Rs.10,000/- along with other fee applicable from time to time. Further a Foreign student passing the qualifying examination from any Indian/ Foreign University will have to come through the Admission Rules.

#### 4. ELIGIBILITY FOR ADMISSION:

Any person who has passed the qualifying Graduate / Degree Examination of Berhampur University or any other examination conducted by other Universities/ Institutions which is recognized as equivalent thereto by Berhampur University and Bar Council of India with 45% of marks(40% marks for candidate belonging to the Scheduled Caste and the Scheduled Tribe) in aggregate is eligible for admission into LL.B. course.

Other Criteria: For candidates, who have passed more than one qualifying examination, the examination in which they have secured the highest marks shall be considered for determining eligibility provided they must have secured 45% of marks (40% for SC/ST) in aggregate in Degree level.

**Selection Criteria of Applicants for Admission:** Selection will be made strictly on merit basis taking into consideration the aggregate marks of the qualifying examination.

**N.B.:** Candidates who have obtained +2 Higher Secondary Pass Certificate or First Degree Certificate after prosecuting studies in Distance or Correspondence method shall also be considered eligible for admission in the Three-year LL.B. course. However, the applicants who have obtained 10+2 or Graduation/Post Graduation through Open Universities system directly without having any basic qualification for prosecuting such studies are **not** eligible for admission into the Law Course.

#### 5. RESERVATION AND CONCESSIONS:

#### i. Scheduled Caste and Scheduled Tribe:

(a)38.75% (Thirty Eight and Three fourth) Percent of the sanctioned strength is reserved for candidates belonging to the Scheduled Caste and the Scheduled Tribe (S.C. 16.25% and S.T. 22.5%). In order to claim reservation under these categories, applicants must submit necessary certificates to this effect issued only by a Revenue Officer of the locality not below the rank of a Tahasildar of the Govt. of Odisha. (b)The reserved seats are not interchangeable between SC and ST. (c)SC/ST applicants selected for admission on their merit shall not be counted against reserved seats. Persons with Disabilities (PwD) selected on their merit without relaxed standards alongwith other candidates shall not be adjusted the reserved share of vacancies. The reserved vacancies shall filled up separately with disabilities which will thus comprise persons with disabilities who are lower in merit than the last candidate in General Merit List but otherwise found suitable as an applicant, if necessary by relaxed standard available for persons with disabilities in addition to the SC & ST candidates. (d)SC/ST applicants selected for admission on their merit shall not be counted against reserved seats. (e) However any modification made by the Government in the reservation policy will be followed during admission.

#### ii. Persons with Disabilities (PwD):

**5%** of sanctioned seats shall be reserved for PwD students with extent of disability not below 40%(Blind and Low Vision, Hard of Hearing, Locomotor Disability including Cerebral Palsy, Leprosy Cured, Dwarfism, Acid Victims and Muscular Dystrophy, Autism Intellectual Disability, Specific Learning Disability and Mental Illness). For availing such reservation the candidate has to submit a certificate from **C.D.M.O**.

iii. Ex-Serviceman [ESM], Serving Defence Personnel [SDP], Children of Martyrs [CoM]

1% of the sanctioned seats shall be reserved for Self / Children / Wife / Husband of ExServiceman, Serving Defence Personnel & the Children of Martyrs.

#### iv. Sports and Games Weightage:

One Seat is reserved for the Applicants who have represented the country in the International Games and Sports during last three years for admission into this course. In case of non-availability of such candidates, the reserved seat will be filled from common merit .

#### (a) Weightage for Sports Persons:

- i) Applicants who have represented the State during last three years at National level sports shall be given weightage an additional 10% of marks over and above the aggregate marks in the qualifying examination.
- ii) Applicants who have represented University at the Inter University Sports during last three years shall get 5% weightage of marks over and above the aggregate marks in the qualifying examination.

Such candidates under category (i) and (ii) must submit a certificate to the effect in the proper format (but not in the form of a testimonial) as prescribed by sports bodies, from the Registrar of the University or Secretary Sports Council/State/National level sports bodies duly countersigned by the Head of the Institution/Principal in which the sportsperson was studying at the time of achieving the above distinction(s).

No fee will be collected from PwD and Transgender /Third Gender(TG) candidates..

#### 7, POSTAL ADMISSION PROCEDURE:

For admission into LL.B. Course the Lingaraj Law College has adopted postal Admission system.

#### i)Provisional list of the candidates

Those applicants are selected in Provisional list for Admission into 3 years LL.B. CBCS Course, after receiving the intimation letter for admission by post from Office of the Principal. The candidate should personally attend before the Admission Committee with the following documents in original on the intimated date and time including Bank Draft infavour *PRINCIPAL*, *LINGARAJ LAW COLLEGE*, *PAYABLE AT BERHAMPUR* towards Admission fee.

However the above procedure 7(i) for admission can be changed in view of COVID-19 Pandemic situation i.e. postal admission system shall be adopted by the College.

Undertaking for extension of time or for any other purpose for submission of the following document(s) shall not be accepted.

- i. Mark sheet and certificate in original of H.S.C. or equivalent examination.
- ii. Mark sheet and certificate in Original of +2 examination.
- iii. Mark sheet and certificate in original of Degree or Equivalent examination.
- iv. Mark sheet and certificate in Original of Higher selected degree.
- v. Transfer Certificate/ College Leaving Certificate in Original
- vi. Certificate from appropriate authority for availing of reservation/ exemption if any.
- vii. Three copies of recent colour pass port size photo graph...
- viii. Registration Receipt in Original (for Berhampur University students)
- ix. Duly filled-in prescribed Affidavit in Original (Annexure-I and Annexure-II)
- x. Identity Card data Form
- xi. Affidavit in a Non-judicial stamp paper as per the prescribed proforma enclosed in the Prospectus (Anti-ragging)

#### ii)Waiting List candidates

After receiving intimation letter candidates in the waiting list shall follow the same procedure for admission as laid down in para 7(i) above. However, for candidates in Waiting List, admission is not guaranteed. They would be admitted in order of merit in case vacancies arise within the date prescribed.

- (8) While preparing the Merit and Waiting list of candidates in case of a tie between two or more candidates the inter-se merit shall be determined by taking into account, the higher marks secured by candidates in the qualifying examination then it follower by the percentage of aggregate marks at the +2 level.. In case of +2 mark being identical, the applicant born earlier will get the higher rank.
- (9) Admission cannot be claimed as a matter of right.
- (10)All admission are provisional and shall be cancelled at any point of time for any valid reason such as forged/manipulated documents or misconduct etc.
- (11)The "CLC/ Transfer Certificate, Mark sheets of qualifying examination and Demand Draft must be submitted on the date mentioned in the Intimation Letter". **Undertaking for extension**

of through personal attendance, date or time for any other purpose for submission of the said documents shall not be accepted. If admission will be through postal correspondence then the above documents and demand draft must be reched on or before the date mentioned in the intimation letter..

- (12) Failure to take admission by the date and time specified in the Intimation Letter shall result in forfeiture of the seat.
- (13) The decision of the Principal of the College in all matters relating to the admission shall be final and binding on all concerned.
- (14) Regarding postal delay the College Authority will not be responsible.
- (15)No Hostel facilities are available for the students of the Lingaraj Law College.
- (16)Applications (hard copy) incomplete in any respect are liable to be summarily rejected. No correspondence in the matter shall be entertained.
- (17) *Disputes :* All disputes concerning admission and studentship are subject to the exclusive jurisdiction of the Civil Court and Legal forums at Berhampur ( Ganjam )
- (18).Ragging: Ragging in any form is an offence and punishable under Law. It is mandatory for all the applicants to submit an affidavit in a non-judicial stamp paper as per the prescribed proforma enclosed in the prospectus (Annexure-I and II), if admitted.
